### *Waiver and Release of Liability*

3. **Waiver and Release:** Participant understands and acknowledges that this Release discharges Signature Event Solutions LLC from any liability or claim that the Participant may bring against Signature Event Solutions LLC with respect to any bodily injury, personal injury, illness, death or property damage that may result from Participants use and possession of Signature Event Solutions LLC equipment.: Participant does hereby release and forever discharge and hold harmless Signature Event Solutions LLC and its successors and assigns from any and all liability claims, and demands of whatever kind or nature, either in law or in equity, which arise or may hereafter arise from Participants possession and use of Signature Event Solutions LLC equipment.
